## **Team Composition & Allowable Line-up Changes for each competition discipline**

1. The table on the following page has been created using both the information supplied by the discipline reps and information regarding allowable team-compositions as described by the FAI Rules found on the FAI website at <http://www.fai.org/ipc-documents>
2. This table is designed to give competitors of all disciplines a more specific description of the team line-up changes that will be allowable post National Championships/Qualifying Event. The changes detailed will allow a team to continue as the qualifying team under that team's registered name when considering either applying to the BPA for sponsorship and/or accepting an invitation to represent the NAC at an FCE. A team will only be eligible to exercise the privileges/invitations of its qualifying championship position gained at the previous qualifying event if it continues within these permitted changes using the same team name.
3. Should there be any extreme/extenuating circumstances that result in a specific team believing that the BPA should consider any alleviation to these rules – application should be made to the Competitions Committee via the Committee Secretary: [skydive@bpa.org.uk](mailto:skydive@bpa.org.uk) at the earliest possible opportunity. Delay may result in alleviations not being able to be considered.
