



## Nomination for Chair of BPA Riggers' Subcommittee for 2019

- Proposed and seconded nominations of candidates to stand for Chair of the 2018 Riggers' Subcommittee of STC **must** be received at the BPA Office by **no later than noon on Friday 26 October 2018**. The candidate must be at least a BPA Advanced Rigger. The proposer and seconder must both be current members of STC. All must be current full BPA members. Nominations may be made by e-mail to [trudy@bpa.org.uk](mailto:trudy@bpa.org.uk) or by post or fax to the address in the above header. **Proof of sending a nomination cannot be accepted as proof of receipt. It is the candidate's responsibility to check to ensure that all parts of their nomination (including from their proposer and seconder) have been received at the BPA Office.**
- Nominations made by e-mail - up to three e-mails per nomination, (a) to (c) below - must include the following, and be sent from the e-mail address of the member (candidate, proposer or seconder) as recorded on the BPA Membership database. For the nomination to be valid, **all three** components of the nomination must be received at the BPA Office by no later than the date and time set out in 1 above.
  - An e-mail from the candidate headed "**Chair Rigger' Subcommittee Candidate - [Candidate's name]**" to include the candidate's declaration as specified below together with the candidate's statement.
  - An e-mail from the proposer: "**Proposer of [Candidate's name]**".
  - An e-mail from the seconder: "**Seconder of [Candidate's name]**".

It is the responsibility of the candidate to ensure that their proposer and seconder have seen, and are content with, their candidate statement. Proposers and seconders should agree to act as such only if they are content with the candidate's statement of their nominee.
- STC Members will elect the Chair of the Riggers' Subcommittee at the STC Meeting of 15 November 2018. If the elected chair is not a member of STC, the successful candidate will need to be co-opted to STC (non-voting). The candidate statement will be sent to STC members with the Agenda for the November meeting.
